**Sub: Status of initiative undertaken by the state on Homeless shelter in the writ 196/2001.**

Dear Shri. Kumar

As you are aware, in our capacity as Commissioners of the Supreme Court in CWP 196/2001, PUCL v. UOI and others, we monitor the implementation of the food and employment related schemes in the country which fall under the purview of the case including the ICDS, MDMS, NREGA, NOAPS, TPDS, NMBS/JSY and NFBS.

In this connection, you must be aware of that recently the Supreme Court has passed many orders which direct the state government to take steps to support the rights of homeless persons in the urban areas. In this connection, we would like to know the initiatives under taken by the state government to provide shelters to the homeless people in the cities, and the other directions of the Supreme Court connected with rights of homeless people, including residential schools for homeless children and community kitchens.

Based on the affidavits filed by the state government before the Supreme Court, we have tried to assess the status and the requirement of shelters in your state. Please find annex 1 for details. As per the ratios directed by the Supreme Court, the minimum numbers of 24 hour permanent homeless shelters required in the state is 12: in the cities Dehradun (6), Haridwar (3) and Nainital (3). We are happy to note that the state government has agreed to provide land free of cost to construct new permanent shelters in the urban in the cities. It has also functioning night shelters in Dehradun (1), Hardwar (2) and Haldwani (1). It is also good to see that the state government has agreed to enhance the accommodation in the shelters, provide basic amenities and regular health check up in the shelters. However no information has yet been made available on details of shelters planned, services being set up, present status of implementation and other operational matters. We would also like to request you that all night shelters should be upgraded to 24 hour permanent shelters.

We would like to request you to kindly submit the detailed status report on the following within 15 days of receiving the letter.

- As per directives of the Supreme Court the state government should have been undertaken survey to find out number of homeless in the city, so please provide details of findings of survey (if undertaken) in the said cities. If not completed please provide timeline for completion of survey, immediately. This survey should indicate the concentration areas of the homeless, and the age, gender, occupational and special needs profiles of each concentration area.
- The information from this rapid survey would help government plan which category of shelters (single men, women, disabled and aged etc shelters) are required in what numbers in various homeless concentration areas of the city. Kindly give details of these plans, including total number of shelters constructed and/or planned, for general as well as special categories; and basic amenities planned to be provided. Please indicate the timeline for completing these.
- Please inform immediately what steps are being taken by the state government to implement the above plans?
- Also please provide details of state policy on the homeless if any; and plans to meet Supreme Court directives.



We would also like to request you take the following four points in to your account while taking decisions/ initiating any work over the homeless shelters issue.

1. It is not necessary to think only of new buildings for shelters. There are other options available too, to meet SC directives and provide the required services to the homeless: refurbishing existing government buildings (community centres, and vacant municipal or state government buildings, just to name a few); vertical expansion of these buildings; even renting out private buildings where no government building (or land) is available. Porta cabins too could be tried as a last resort.
2. Location of shelters is going to be key to the long term success of the programme. These should be appropriate for homeless persons, near where they mostly seek and get work. It is important that state government decide on the sites through a consultative process of discussions and engagement with homeless persons/organizations representing them. A rapid survey of available sites and buildings, through this consultative process, should be made before embarking upon site development.
3. State government must ensure a satisfactory mix of women's and men's shelters, and those for other vulnerable populations. Also see that these are properly equipped, planned and serviced.
4. State government must also think through the operational, management and oversight arrangements for shelters. These should meet the criteria of quality provision, client satisfaction and user involvement.
