## ORDER

In re: State of Andhra Pradesh:

As far as State of Andhra Pradesh is concerned, learned counsel appearing for the State, who has just received instructions, prays for some time. We grant two months' time to implement all previous orders of this Court. An affidavit may be filed by the concerned Secretary/Chief Secretary within two months.

#### In re: State of Bihar:

In pursuance to the directions of this Court, on 2nd June, 2010, the Chief Secretary, State of Bihar has filed an affidavit. In the said affidavit it is indicated that considering the importance of the subject, the Hon'ble Chief Minister has convened a high level meeting which was attended by the Minister of Health, Minister for Food and Consumer Affairs. Minister for Social Welfare Department, Advocate General. Standing counsel for the State of Bihar in the Supreme Court, The Chief Secretary, Development Commissioner and Secretaries of the departments concerned were also present. Hon'ble Chief Minister was of the view that the recommendations made by the Court Commissioner is indeed in public interest and would subserve a noble cause. The recommendations, on their implementation, would go a long way in mitigating the plight of those people of the State who have no shelter and no means to afford minimum food requirement. In the meeting it was decided that, as a first step, three new shelters in each of the divisional towns of Chapra, Muzaffarpur, be constructed at Patna and one Darbhanga, Saharsa, Purnia, Bhagalpur, Munger and Gaya for urban homeless. The Department of Urban Development and Housing has already initiated steps for release of funds to the concerned Municipal Corporations/Town Committees. It has been decided in the said meeting to renovate the permanent/night shelters in each of these towns. It has further been decided to make arrangements for meals for urban homeless people at subsidized rates. In addition, it has been decided to conduct a survey of urban homeless people under the guidance of the Department of Urban Development 7 W.P.(C)No.196/2001 Contd....

and Housing. It has been decided that the Department of Urban Development and Housing would ensure admission of homeless—street children in the existing—residential schools.—In the affidavit it was also incorporated that the—Department of Urban Development and Housing has sanctioned—a—sum—of Rs.1.86 crore—to—the—Municipal Corporations/Town Committee concerned vide letter dated

20.05.2010. The Department of Urban Development and Housing has earlier vide their letter dated 15.05.2010 had directed the concerned Municipal Corporation/Town Committee to initiate steps for establishing the shelters. We are very happy to note the change of attitude in the stand of the State. The State has also mentioned in the affidavit that the State of Bihar fully shares the anxiety of the Court and assured the Court that it shall take all possible steps which would go to

ameliorate the living condition of homeless people and unprotected children. We hope and trust that all the shelters shall be constructed as expeditiously as possible, in any event, before the next winter.

In re State of Goa:

Ms. Subhashini, learned standing counsel appearing for the State of Goa submitted that the problem of homeless people which require night helter/permanent shelter does not exist in Goa, except for the migrated people. Learned counsel for the petitioner may inquire about it and submit an affidavit.

In re State of Gujarat:

Learned counsel appearing for the State of Gujarat undertakes to file a better affidavit. Let the affidavit now be filed by the Chief Secretary of the State.

In re State of Jammu & Kashmir:

Learned counsel appearing for the State submits that he will file a comprehensive affidavit within two months.

In re State of Jharkhand:

ON 31.03.2010, an affidavit was filed by the State of Jharkhand in which it was mentioned that funds have already been allocated for construction of night/permanent shelters in the State and they are planning to develop night/permanent shelters in Ranchi, Dhanbad, Chaibasa, Deoghar and Jasidih

municipalities. Learned counsel appearing for the State prays for some to file the latest status report. Let that be filed within two months.

#### In re State of Karnataka:

Mr.Sanjay Hegde, learned standing counsel for the State has handed over an affidavit of the Chief Secretary to the State of Karnataka in Court today. In the affidavit it is mentioned that a meeting was held under the Chairmanship of the Additional Chief Secretary to Government, Urban Development Department on 17-06-2010 and it was decided to conduct a detailed survey to provide night/permanent shelter. It was further indicated in the affidavit that the entire survey would be completed by the end of August, 2010 and immediately after the survey is completed, concrete efforts would be taken to provide permanent/night shelter for the homeless people in the State of Karnataka.

#### In re State of Kerala:

Learned counsel appearing for the State of Kerala submitted that the intensity of the problem does not exist in the State of Kerala. Learned counsel appearing for the petitioner prays for some time to file a report

about the State of Kerala. Let the report be filed within two months.

## In re State of Maharashtra:

Learned counsel appearing for the State of Maharashtra submits that, in principle, the Government has agreed to provide shelters for the homeless. The modalities are being worked out. He prays for four weeks time to communicate the decision of the State. List after four weeks.

#### In re State of Punjab:

Learned counsel for the State prays and is granted four weeks' time to communicate the decision of the State. List after four weeks.

## In re State of Rajasthan:

The Chief Secretary to the State of Rajasthan has filed an affidavit in which it is incorporated that an order was issued by the State on 07.12.2009 to all the urban local bodies including municipal corporations for construction of night shelters. It is also mentioned in the affidavit that all the municipalities of the State are running 240 night shelters. It was also mentioned in the affidavit that new guidelines have been framed for providing persons providing shelter not shelter to the homeless only confining during winters but also in summers as the temperature soars to about night shelter State. The broad contours of the guidelines would indicate that the degree centigrade in the State undertake to make necessary provision of clean potable water and other infrastructure to ensure dignity of an individual. They have also given the guidelines which have been incorporated for the homeless people.

#### In re State of Sikkim:

On 31.03.2010, an affidavit was filed on behalf of the State of Sikkim in which it was mentioned that the State Government has started to construct 52 units for housing of urban poor and the same is at the verge of completion. We grant two months time to the State of Sikkim to submit the latest status report.

## In re State of Tamil Nadu:

Mr.Mohan Parasaran, learned Additional Solicitor General appearing for the State of Tamil Nadu submitted that, in principle, the State has agreed to provide night/permanent shelters to the homeless and prays for

some time to file an appropriate affidavit. Let that be done within four weeks. List after four weeks.

In re State of Uttar Pradesh:

Mr.Promod Swarup, learned senior counsel appearing for the State of Uttar Pradesh submits that the State, in principle, has agreed to comply with the order and in pursuance of the order of this Court 7 permanent and one temporary shelter have already been constructed and the remaining shelters would be constructed as expeditiously as possible. We would like the State of Uttar Pradesh to file the latest status report within four weeks.

In re State of West Bengal:

Mr.T.C.Sharma, learned standing counsel appearing for the State of West Bengal submits that he has sent three communications to the Chief Secretary as well as to the Nodal Officer but he is not getting any response. On the next date of hearing we would like the Chief Secretary and the Nodal Officer of the State to remain present in Court, if the affidavit is not filed.

## In re Chandigarh:

The Union Territory of Chandigarh has not filed any affidavit after the order of this Court dated 05.05.2010. One more opportunity is granted to the Union Territory of Chandigarh to file an affidavit. Let the same be filed within four weeks, failing which the Chief Secretary of Chandigarh shall remain present in Court on the next date of hearing.

In re GNCT of Delhi:

In the last affidavit filed in April 2010 by Government of National Capital Territory of Delhi, they assured the Court that required number of night/permanent shelters would be constructed and all possible amenities

would be provided. We expect the Government to construct the night/permanent shelters in Delhi latest by 31st October, 2010 because the winter starts setting in thereafter. Learned Additional Solicitor General undertakes to file a comprehensive affidavit within four weeks.

In re State of Madhya Pradesh:

Learned counsel appearing for the State prays and is granted four weeks time to file the latest status report. List after four weeks.

In re State of Haryana:

The matter has been passed over for once and called for second time. No one appears on behalf of the State of Haryana and no affidavit has been filed after 05.05.2010, as directed by this Court. We would like the Chief Secretary of the State to remain present on the next date of hearing, in case the affidavit is not filed.

In re State of Orissa:

The matter has been passed over for once and called for second time. No one appears on behalf of the State and no affidavit has been filed after 05.05.2010, as directed by this Court. We would like the Chief Secretary of the State to remain present on the next date of hearing, in case the affidavit as directed by this Court is not filed within four weeks.

Let all the States, which were required to file their affidavits after the order of this Court on 05.05.2010 and who have not filed, they are given one more opportunity. Let the affidavit be filed within four weeks. List this matter on 31.08.2010 for directions.

I.A.No.98:

This application has been filed on behalf of Union of India, Ministry of Health and Family Welfare in which they have sought following directions:

- to permit Union of India to continue implementation of Janani Surakhsa Yojana in terms of the observations made by this Hon'ble Court in para 15 of the order dated 20.11.2007 and in terms of the existing guidelines by duly taking into account that the salient features of National Maternity Benefit Scheme have been duly incorporated and subsumed in Janani Suraksha Yojana,
- 2. to modify the direction contained in para 14(b) of the order dated 20.11.2007 and permit Union of India to provide cash assistance of Rs.500 in case of home deliveries to pregnant women for upto the first two live births, provided they are of 19 years of age,
- 3. to permit the continuation of the system of payment of Janani Suraksha Yojana to the woman after the delivery instead of 8-12 weeks prior to delivery. Issue notice. Non-applicants would be at liberty to file reply to this application within four weeks and to come up on 31.08.2010.

In this writ petition, a report has been filed by the Commissioners in which it has been prayed that there is urgent need of night shelters in urban areas. In the report, it is prayed that the Centre and the State Government be directed to provide permanent 24 hours homeless shelters in the areas beginning with 62 cities and towns across

In the report it is also mentioned that these homeless shelters need to be opened 24 hours in all seasons, and should have basic amenities to life enable a with dignity. Ιt is further incorporated in the report that winter is a period of severest crises for homeless people and it is directly life threatening, though all seasons pose threats to homeless people. Homeless people are subject to continuous violence and abuse. Living in the open with no privacy or protection even for women and children, is a gross denial of the right live with dignity. For this reason the Commissioners are convinced that unless directions are given by this Court, the problems would not be solved.

It is further stated in the report that the shelters should have the basic facilities, such as, beds and bedding, toilets, potable drinking water, lockers, first aid, primary health, de-addiction and recreation facilities. It is also mentioned that shelters must be in adequate numbers and in the ratio of at least one per lakh of population for every urban centres according to the Delhi Master Plan.

The matter was discussed and the learned Additional Solicitor General appearing for the Union of India submitted that all major cities, which have population of more than five lakhs, will be provided with night shelters in the ratio of at least one per lakh of population.

This Court issued notice to all the States and Union Territories. In response to the notice, most of the States and Union Territories have filed affidavits and their responses are as under:

State of Madhya Pradesh:

The State of Madhya Pradesh has agreed to construct one night shelter for a population of one lakh in all urban centres.

Further it has been directed that-

all local bodies within their territorial limits night shelters will construct for homeless people; normally at least one night shelter in population of one lakh must be constructed and homeless persons residing in the provided shelters should be clean drinking water, light, toilet and provisions for their

made for fire with the funds of the local bodies and with the cooperation of the working social organisations blankets be also arranged for the persons staying in night shelters. in coordination with the local health officer, urban bodies should make arrangements for investigation of health of all those poor persons staying in night shelters and will make giving treatment arrangements for in the Government hospitals; as per the requirement of security of the goods the poor persons residing in the night shelter, locker facility should also be provided; separate place be provided for men and women in night shelters; at the local level all the urban bodies with the cooperation of the working social organisations should also make arrangements for the supply of on reasonable rates to poor residing in the night shelter; The above arrangements may be immediately made the night shelters which have been constructed earlier by the local bodies, the State Government has directed that within six months, Commissioners of Municipal Corporations and Chief Municipal Officer, make Municipality should a survey of the homeless.

Pradesh is very positive. We direct the State

#### State of Nagaland:

In the affidavit, which has been filed on behalf of the State of Nagaland, it is mentioned that the State Government proposes to conduct a detailed survey through its own department or by engaging reputed organisations/institutions within a period of six months for all urban areas within It is also mentioned that depending the State. upon the results of the detailed survey, shelter homes would be constructed in a phased manner as may be necessary. The shelter homes will have basic requirements necessary for providing safe, secure and comfortable shelter for the homeless. We expect the State of Nagaland to file an affidavit within a period of two months to ensure that entire programme is implemented.

State of Mizoram:

The State of Mizoram has stated in the identification of affidavit that urban homeless will be conducted in a comprehensive manner within months and necessary facilities would provided to the homeless in the shelters. In view of this affidavit, no further directions are warranted at this stage.

State of Rajasthan:

Learned Additional Advocate General appearing for the State of Rajasthan submits that formulation of the comprehensive policies would take about two months.

We direct the Chief Secretary of the State of Rajasthan to file an affidavit within two months indicating the progress made by the State in respect of providing shelters to the homeless in accordance with the standard norms.

#### State of Arunachal Pradesh:

An affidavit has been filed by the State of Arunachal Pradesh indicating that the problem does not exist in the State except in Itanagar where the population is more than one lakh. It is mentioned the affidavit that in "there is nobody who is homeless or orphan. In the event of death and demise of parents, village community takes over the responsibilities for the children leaving little or no scope for the destitution".

It is indeed a very happy situation in the State of Arunachal Pradesh but as regards Itanagar, an affidavit be filed within two months.

### State of Gujarat:

In the affidavit filed by the State of Gujarat, it is mentioned that in the State there are four cities with a population of more than five lakhs, i.e., Ahmedabad, Vadodara, Rajkot and Surat. The affidavit is not clear about the issue, which this Court is dealing with.

Therefore, in view of this affidavit, at this stage no further directions are warranted so far as this State is concerned.

#### State of Uttarakhand:

It is mentioned in the affidavit that Dehradun, Haridwar and Haldwani have a population of more than one lakh. One night shelter already in existence in Dehradun and two night shelters are there in Haridwar. Haldwani also has The State Government has issued one night shelter. directions to all the urban bodies to provide land free of cost for the establishment of additional night shelters in order to construct shelter for the entire shelterless people. In the affidavit it is also mentioned that the urban local bodies are for also directed to submit proposal the upgradation of existing night shelters basically for enhancing their accommodation capacities and to provide basic amenities, such as, blankets, potable drinking water, toilets, electricity connections, and regular health checkups.

considered view, no further directions need to be issued as far as State of Uttarakhand is concerned at this stage.

#### State of Assam:

In an additional affidavit filed on behalf of the State of Assam, it is mentioned that they will undertake the survey and engage reputed organisations/institutions for this purpose and on the basis of the survey, additional shelters would created or the existing shelters will be upgraded in the phased manner, as may be necessary. shelters will have the basic requirements necessary for providing safe, secure and comfortable shelter for the homeless. We direct that an affidavit be filed by the Assam within a period of two months indicating whether the process has started or not.

#### State of Kerala:

affidavit filed on behalf of the the In State of Kerala, it is mentioned that nine shelters for the homeless have been established in the nine districts of Kerala.

In view of this affidavit, no further affidavit for the time being is required to be filed by this State.

UPON hearing counsel the Court made the following O R D E R  $\,$ 

In pursuance to the order dated 10.2.2010 following passed by this court, States Union and Territories have field their affidavits: Tamil Nadu, Assam, Chhatisgarh, Rajasthan, Haryana, Bihar, Kerala, West-Bengal, Manipur, Uttaranchal, Himachal Pradesh, Guajrat, Tripura and Maharashtra. One more opportunity is granted to the remaining States and UTs to file their

respective affidavits failing which concerned Secretary of the State shall remain present in Court. The affidavit shall be filed within two weeks from today with an advance copy to the petitioner, learned counsel for the Union of India. Rejoinder, if any, to the said affidavit be filed within one week thereafter. On the next date of hearing, I.A.No. 90, 94, 96 and 98 would be taken up for hearing and immediately after conclusion of these I.As. other subject matter would be taken up for hearing. The counsel are directed to complete pleadings and take instructions in those I.As.

Mr. Mohan Parasaran, learned ASG appearing for the Government of Delhi has submitted a compliance report in pursuance to the order of this Court dated 10.2.2010. In the Status Report it is indicated that grant of AAY status to homeless people, the quantity of specified food articles to be supplied is 25 Kgs. of wheat and 10 Kgs. of rice, 6 Kgs. sugar and 22 litres of kerosene oil ( if not a gas user). However the rates of wheat and rice are less for AAY card holders but rate of sugar and kerosene oil is the same for both categories. Since AAY card holders for homeless are mostly for a single person, quantity of wheat and rice has been fixed — at 10 Kgs. and 5 Kgs. respectively and kerosene oil 10 litres per month. Provision for supply of specified food articles is made for 14850 card holders with effect

from March 2010.

It is also mentioned in the Status Report that the Government of N.C.T. of Delhi has created a Committee for Homeless under "Mission Convergence" and has also appointed NGOs for the purpose of distributing cards for homeless as well as for surveying the further eligible homeless people.

It is further submitted in the Status Report that survey of homeless people was carried out by the Mission Convergence (Samajik Suvidha Sangam) and two phases are already over.

The Chief Secretary in Meeting dated 22.1.2010 desired the survey of homeless people already undertaken by the Mission to be completed by 31.5.2010 so that the cards can be issued to the homeless people. Regarding the issuance of grant of AAY cards to homeless instead of BPL, it is submitted that there is a survey being carried out identifying by the Mission for vulnerable and most vulnerable household. homeless would Further identified under that survey and whatever benefits are given to them will also be given to 14850 homeless people identified by SAMYA-NGO including those cards already issued. The features of Mission Convergence Scheme have already been highlighted in the affidavit.

It is also mentioned in the Status Report that issue of

AAY cards to Myanmar refugees who fall below the poverty line, the Mission has been requested that while conducting survey of homeless, vulnerable and most vulnerable household living in Delhi, the Myanmar refugees be also surveyed and a separate report will be submitted in respect of those who are found eligible so that their case could be considered for issue of cards. Mr. Parasaran submits that a proper affidavit will also be filed by the concerned Secretary to the Govt. of N.C.T. of Delhi explaining these aspects and other aspects within two weeks.

Learned counsel for the petitioner has placed copy
of the extract of main recommendations of Justice
Wadhwa Central Vigilance Committee Report. The counsel
for the parties would be at liberty to obtain copy of the
same from the Registry on usual payment.

I.A.No.90 filed by the State of Maharashtra, copies of the same have been given to the learned counsel for the parties. Reply to this application be filed within two weeks with an advance copy to the learned counsel for the applicant. Rejoinder, if any, to the said reply be filed within a week thereafter.

I.A.No.98 filed by the Ministry of Health and Family

Welfare. Reply to the said application shall be filed within two weeks. Rejoinder, if any, within a week

thereafter.

I.A.Nos.90, 94, 96 and 98 would be taken up for hearing and disposal on next date of hearing.
